**ROLL CALL:**

**MINUTES:**

Minutes from the July 15, 2020 Regular Session were submitted for approval. Member Harley moved to accept the minutes as written. Member Gibson seconded; motion carried unanimously.

**OLD BUSINESS:**

**Attorney Report:**

Attorney Jones presented Resolution 2020-13 ERA for Altium LLC. to the Council for consideration. Member Harley motioned to accept Resolution 2020-13 as written. Member Partin seconded; motion carried unanimously.

Attorney Jones then presented Ordinance 2020-06 Revision of the Golf Cart Ordinance. Attorney Jones explained that this Ordinance is to revise the current golf cart ordinance to allow golf carts to ride on state owned roads in Argos. A discussion was had regarding registration fees for golf carts like other towns have. After the discussion, Vice President Snead motioned to accept Ordinance 2020-06 on the first reading and amend it to include an annual registration fee of \$40.00. This fee would expire in June and cover until the next June. Member Gibson seconded; motion carried unanimously.

Attorney Jones then informed the Council he reviewed the appointment of Ken Harrington to the Argos BZA and he meets all the requirements. Mr. Harrington is now an executive appointment to the BZA.

Attorney Jones also stated he has a meeting scheduled with Chief Bowman and Councilman Harley to review the nuisance policy. That will be around August 18<sup>th</sup>.

With no more business to present to the Council, Member Partin motioned to accept the attorney's report. Member Gibson seconded; motioned carried unanimously.
