CALL TO ORDER

Council President Mark VanDerWeele called the meeting to order at 7:36 PM.

ROLL CALL

Present for the meeting: President Mark VanDerWeele, Vice President Suzanne Umbaugh, Members Casie Rowe, Dustin Johnson, Clerk-Treasurer Patty Jones and Town Attorney Derek Jones. Member George Null was absent.

MINUTES

Minutes from the October 7^{TH} Public Hearing and Regular Session were submitted for approval. Council Member Rowe moved to accept the minutes as presented and Council Member Johnson seconded. The motion carried unanimously.

APHEUS SOLUTIONS

Bob Barcus discussed technical issues with the town emails and major security concerns and what he has done to fix the situation. The Council thanked him for coming and explaining the problems.

CITIZEN INPUT

Brenda Hutchison thanked the Council for bringing in the dumpster for residents to use. Mrs. Hutchison also said that she really enjoys seeing the fall decorations downtown.

Resident Robert Luce said that property owners were asking him about a revitalization committee supposedly started by Chris VanDuyne and asked the council if it was sanctioned by the town. The council responded that they knew nothing about it.

OLD BUSINESS

Attorney Report:

Attorney Derek Jones said that he met with REMC and their attorney to discuss service territory issues. More research on the history of the service territory is needed to determine the next step.

Mr. Jones handed out the annual nepotism certifications for the town elected officials to sign.

Derek discussed that the council needs to review the current farm lease and decide at the next meeting whether to make changes so that he can get it published for bidders to farm it in 2016.

Council Member Rowe moved to accept the Attorney Report and Vice President Umbaugh seconded. The motion carried unanimously.

Water Bonds:

Derek said that if the Council chooses to move forward on paying off the water bonds with electric utility funds to save interest there is a process to go through with the bond council and rural development as an earlier email from Eric Walsh explained. Vice President Umbaugh moved to have Derek contact the bond council and Council Member Rowe seconded. The motion carried unanimously.

Board Openings- MC Tourism, Maple Grove Cemetery, Argos Redevelopment Commission:

There was a letter of interest for the Argos Redevelopment Commission from Dylan Colburn. Vice President Umbaugh moved to appoint Dylan and Council Member Johnson seconded. The motion carried unanimously. No other letters of interest this meeting.

Ordinance 2015-9/ 2016 Budget:

Council Member Rowe moved to pass Ordinance 2015-9 on the second and third reading and Vice President Umbaugh seconded. The motion carried unanimously.

NEW BUSINESS

Resolution 2015-11/ Additional Appropriations:

Council Member Johnson moved to pass Resolution 2015-11 which allows for the additional appropriations of \$33,000 out of the LRS fund for payment on a new dump truck and Council Member Umbaugh seconded. The motion carried unanimously.

Resolution 2015-10/ Power Tracker:

Vice President Umbaugh moved to accept Resolution 2015-10 and Council Member Rowe seconded. The motion carried unanimously.

Other New Business:

Mr. and Mrs. Pennington told the Council that they were interested in buying the town owned property that adjoins theirs on the corner of Broadway and West. Attorney Jones explained that the land purchase process requires appraisals and then bidding. Council Member Johnson moved to go forward with the process and Vice President Umbaugh seconded. The motion carried unanimously.

DEPARTMENT HEAD REPORTS

Utilities- Utilities Superintendent Jim Burroughs was not present at this meeting.

Police Department- No questions for Chief Bowman this meeting.

Fire Department- Fire Chief Mark Dean was not present at this meeting.

EMS- EMS Director Rich Miller was not present at this meeting.

Council Member Rowe moved to accept the Department Head Reports and Council Member Johnson seconded. The motion carried unanimously.

CLAIMS

Clerk-Treasurer Jones read the top five claims which totaled \$1,396,290.07 and represented 95% of the total docket. The total claim docket was in the amount of \$1,464,130.41. Council Member Rowe moved to accept claims 1033 through 1083 and Vice President Umbaugh seconded. The motion carried unanimously.

With no more business brought before the board, Council Member Rowe moved to adjourn the meeting and Council Member Johnson seconded. The motion carried unanimously. The meeting adjourned at 8:17 PM.
