

**TOWN OF ARGOS  
REGULAR COUNCIL MEETING  
WEDNESDAY, MAY 18, 2022 @ 7:00pm**

**CALL TO ORDER:**

Council President Charles R. Snead called the meeting to order at 7:04 PM.

**ROLL CALL:**

Present for the meeting: President Charles R. Snead, Vice President Shawn Harley, Members George Null, Erica Partin, Angela Resendez, Attorney Derek Jones, and Clerk /Treasurer Lisa Mullaney.

**MINUTES:**

Minutes from the May 04,2022, Regular Session were submitted for approval. Vice President Harley moved to accept the minutes as written. Member Partin seconded; motion carried unanimously.

Attorney Jones informed the Council that four property owners have been notified in writing. What the violations under the unsafe building ordinance are and they have 30 day from the time of the letter to repair their houses or at the least contact Mr. DeWitt to form a resolution to the situation.

Attorney Jones then stated that the bid for the PD/Utility Storage buildings has been published and bid opening will be June 13<sup>th</sup> then the Council can review bids at the June 15<sup>th</sup> meeting.

With no more business to present to the Council, Member Partin motioned to accept the attorney's report. Vice President Harley seconded; motioned carried unanimously.
