Member Snead motioned to accept Ordinance 2024-19 on the second and third readings. Member Byers seconded; motion carried unanimously.

Change Order #1 Water Grant-

After discussion, Vice President Barcus motioned to accept Change Order #1 as written. Member Byers seconded; motion carried unanimously.

Resolution 2024-06 Year End Employee Bonus-

After discussion, Vice President Barcus motioned to accept Resolution 2024-06 as written. Member Harley seconded; motion carried unanimously.

Other New Business -

The Employee Appreciation Dinner this year was held at The Breakroom. After a discussion, Member Harley motioned to have the Clerk-Treasurer reserve the date at The Breakroom for next years dinner. Member Byers seconded; motion carried unanimously.
